ab initio [From the beginning]	A phrase added to the term, VOID, to indicate the time from which a purported contractual transaction is of no effect.
ab Intestat	An heir, ab intestat, is one on whom the law casts the inheritance or estate of a person who dies intestate
ab Irato	Which signifies by a man in anger. It is applied to bequests or gifts, which a man makes adverse to the interest of his heir, in consequence of anger or hatred against him

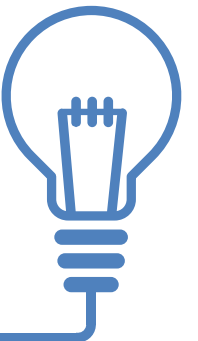

Latin Word	Meaning in English
bona fide	In good faith, honestly, without fraud, collusion or participation in wrongdoing.
possessio civilis.	Civil possession; possession capable of ripening into ownership by usucapio, i.e. if it was free from vitium and held ex justa causa and bona fide.
possessio naturalis.	Natural possession; where a person possessed a thing not ex justa causa and bona fide.

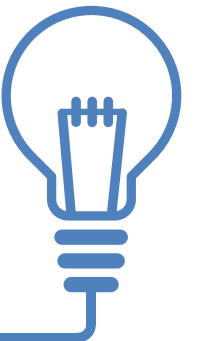

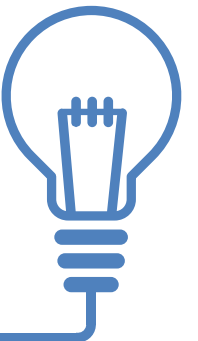
